## **Governor Wolf's Advisory Commission on Asian Pacific American Affairs Hosts Community Symposium**

**Harrisburg, PA** – Governor Tom Wolf's Advisory Commission on Asian Pacific American Affairs (Commission) today hosted its inaugural Asian American and Pacific Islander (AAPI) Community Symposium at the Pennsylvania State Museum, which addressed issues such as the opioid epidemic, domestic violence and sexual assault, bullying, safe schools, and microaggressions.

"We wanted to create a platform for engagement between the AAPI community, and state and local agencies, as well as non-profit providers around these issues that greatly impact our community," Bibhuti Aryal, Chair of the Commission said. "These are issues that we heard over the course of the past 19 months during the 12 community town halls that we held across Pennsylvania, and we wanted to be responsive and ensure that the AAPI community had access to local and state resources as well as generate awareness of the progress made by the Wolf Administration on these important and complex topics."

The community symposium was hosted by the members of the Commission in partnership with local AAPI community leaders from across the Greater Harrisburg region.
